The college concerned shall also submit Original forwarding memo and List of Practical Awards, complete in all respects, e.g. - having details of total Present and absent students, full signature and complete address of the Practical External Examiners with contact No., to the OSD (Conduct),M.D. University,Rohtak, within seven days after uploading the External Practical Award latest by 01.09.2022, failing which late fees will be charged from the College concerned as per University Rules.

- 1. All the students will be required to follow the national guidelines related to COVID-19 as issued by Ministry of Home affairs/State Govt. time to time.
- 2. The Practical Examinations of Reappear students shall be conducted in their respective Colleges ( which they were regular students.
